- September 1: Deadline for FY18 Tribal Plan & application
 - Current grantees in the middle of an accepted two-year plan must submit an updated SF-424M and FY18 Annual Report.





CSBG Tribal Applicant Types

- Prospective/New Applicant: Never applied for CSBG funds before.
 - Provide all necessary documents listed for complete CSBG Tribal Application package <u>EXCEPT</u> or a FY18 Annual Report.
 - Email OCS with EIN & DUNs number along with Tribal-State Agreement Letter.
 - Follow submission directions provided by OCS.





CSBG Tribal Applicant Types (Cont.)

- Returning Grantees: Currently receiving CSBG Tribal funds.
 - One-Year Plan: Grantees at the end of a one-year Plan (10/01/17– 09/30/18)
 - Must provide & submit <u>ALL</u> materials listed for a CSBG Tribal Application Package including the FY18 Annual Report via the OLDC System.





Preparing for CSBG FY19: CSBG Tribal Applicant Types (Cont.)

- Returning Grantees: Grantees in the middle of a twoyear Plan (10/01/17–09/30/19)
 - Must provide & submit <u>ONLY</u> their SF-424M and FY18 Annual Report via the OLDC System
- Returning Grantees: Grantees in the end of a two-year plan (10/01/16 – 09/30/18)
 - Must provide & submit <u>ALL</u> materials for a completes CSBG Tribal Application package including the FY18 Annual Report.
