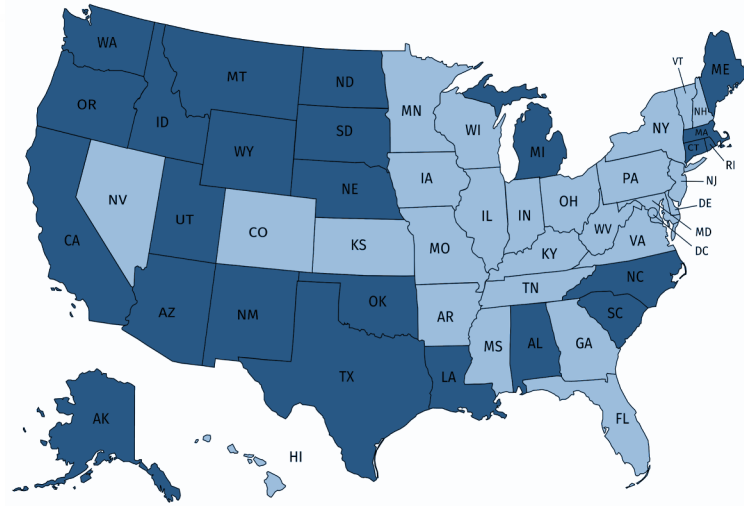

# CSBG Tribal Network

- 66 direct-funded OCS CSBG Tribal grant recipients
- Serving over 148 Native American & Alaska Native Tribes, villages, and communities across 24 states
- Additional Tribal programs receive funding directly through state CSBG programs, such as Minnesota, New York, and California

# Maximizing the Impact of CSBG & CARES Act Funding Workshop

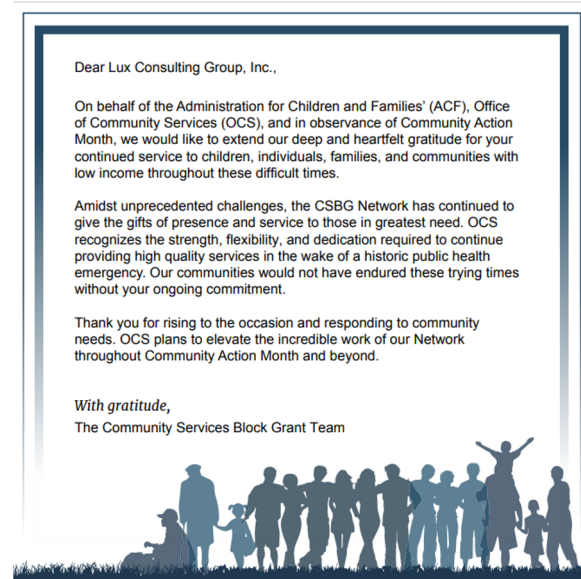

# FY 22 Federal Budget



- President Biden signed a FY 2022 spending bill on March 11
- CSBG Tribal Grant Recipient final FY 2022 allocations are being calculated

# CSBG & CARES Act Supplemental Spending



- Significant increase in funding over the past two years for investments in community services.
- Opportunity to invest in targeted community services, programming, and long-term projects in need of funding.
- Fully spending all available funds is critical.

# Funding Expenditure Deadlines



- FY 2021 CSBG Regular funding & CSBG CARES Act Supplemental funding obligation deadline is September 30, 2022
- FY 2021 CSBG Regular funding & CSBG CARES Act Supplemental funding expenditure/liquidation deadline is December 31, 2022.
